This is an ancient field of law, so it is appropriate that Mr. Weiss will devote much of his presentation to a problem that many thought experienced its "heyday" many centuries ago, yet plagues mariners today with equal or greater ferocity — piracy. This is big, brutal, business involving tens of millions of dollars' worth of cargo and many millions of dollars paid for the recovery of ships and their crews. Piracy is far from dead. Its practitioners are found lurking in the Red Sea, the Indian Ocean, off the Somali Coast, in the Strait of Malacca, Singapore, off the coasts of North Africa and Iran, in the Mediterranean Sea, the South China Sea, the Niger Delta and even, to a lesser degree, in the Caribbean Sea.
